<sup>1</sup>End-of-Life Vehicle Regulations means the End-of-Life Vehicles Regulations 2003 No. 2635 and the End-of-Life Vehicle (Producer Responsibility) Regulations 2005 No. 263, together with equivalent laws in Scotland and Northern Ireland (the S.S.I 2003/593 and S.R. 2003/493 respectively) together with any and all guidance and/or codes of practice issued from time to time.

<sup>2</sup>A vehicle is considered incomplete under regulation 10(7) of the End-of-Life Vehicle (Producer Responsibility) Regulations 2005 No. 263 where the vehicle "does not contain the essential components of a vehicle, in particular the engine, transmission, coachwork, wheels or catalytic converter, if a catalytic converter formed part of the vehicle when it was placed on the market, or contains waste which has been added to it".
